#### <u>ORDER</u>

- A meeting of the Task Force/Implementation Committee constituted in connection
  with the implementation of Grading System in this University was held on 22-04-2009 in the
  University office, Mangatuparamba to finalise Regulation for restructuring of U.G.Courses
  with effect from 2009 admission.
- 2. As per the recommendations of the meeting vide paper read (1), it was resolved to conduct a One Day workshop at State level on introduction of Choice Based Credit Semester System for Under Graduate courses in this University and to convene a meeting of the various U.G and Combined Boards of Studies to arrive at a Draft Regulation on the restructuring of the U.G.Courses, Convenor, Standing Committee of the Syndicate on Affiliation of courses and staff of affiliated colleges was authorised to present the Draft Regulation at the Workshop, and the draft regulation was presented accordingly.
- 3. The Standing Committee of the Syndicate on Course, Research, Library and Publication which met on 09-06-2009, vide paper read (2) above has considered the draft regulation and incorporated certain modifications to the regulation for Choice Based Credit Semester System to be implemented in this University with effect from 2009 admission.
- 4. The modified regulation as approved by the Standing Committee of the Syndicate and the Vice-Chancellor was placed in the Boards of Studies and Faculties and Boards of Studies and Faculties concerned considered the regulation for Choice Based Credit Semester System and approved with certain modifications, as per the paper read third above and accordingly the Regulation stand finalised for implementation.

- 5. The Vice-Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11 (1) of Kannur University Act 1996 and all other enabling provisions read together with has accorded sanction to introduce Choice Based Credit Semester System in this University and to implement the Regulations for Choice Based Credit Semester System with effect from 2009 admission subject to report to the Academic Council and the Syndicate.
  - 6. The following orders are therefore issued in this matter.
  - The Choice Based Credit Sentester System is introduced for U.G.Courses in all affiliated colleges under this University.
  - Regulations for the Choice Based Credit Semester System for U.G.Courses is implemented with effect from 2009 academic year onwards.
  - (iii) Choice Based Credit Semester System for U.G.courses and regulations for the same implemented subject to report to the Academic Council of this University and the Syndicate.
- 7. The regulation for Choice Based Credit Semester System effective from 2009 academic year is appended.
- 8. Orders on implementing the Scheme and Syllabus in line with Choice Based Credit Semester System effective from 2009 academic year will be issued separately.
