14. The Research Guide shall regularly monitor the research activities of the research scholars working under his guidance and report the matter to the University once in six months in the case of part time scholars and once in three months in the case of full time scholars.
15. The Research Guide is bound to follow the rules, regulations and guidelines applicable and issued by the University and UGC from time to time, failing which the University reserves the right to cancel the research guideship granted to him.
16. The Research Guideship will automatically be cancelled if no research scholars are registered under a Research Guide after four years from the date of recognition granted to him as a Research Guide.
17. If the Research Guide feels that Joint supervision is necessary for the research work having inter-disciplinary/multi-disciplinary nature, the service of a Co-Guide may be made available, subject to the condition that the Research Guide has requested for the same, specifying the name of Co-Guide and the approval of the Doctoral Committee.
